MESSAGE FROM THE MAYOR

During the past year, your Board of Trustees along with a number of community residents, has worked hard to enhance our Town. The major project of realigning Fairway Lane and Christiansen Lane at Platte Canyon with the signalization of the new intersection is now complete. We have received many positive comments regarding the project and we trust you are pleased with the results. The real "sparkplug" bringing this project to completion was Trustee Ernie Hambrook and I thank him for his steady commitment.

Following the highway project, we began working on "rebuilding" the entryway on Fairway and it is now complete except for a few final touches on landscaping. This project has been a component of Drainage Way E and was accomplished with the cooperation of many contractors and residents. Another project is burying the utility lines on the west side of Middlefield Road which Xcel says will be completed in the near future.

Internal to our community, development continues on both the Brookhaven and Country Club Villas projects. As of this writing Brookhaven has been issued eight single family house permits and Country Club Villas has been issued three permits. The town home project in Brookhaven will begin completion of the infrastructure in the near future. Requests for permits in this area are anticipated in the spring of 2002.

The fall also brings the annual budgeting process for the Town's 2002 budget. The Trustees are working diligently to structure both the operating and capital budgets for the community in accordance with State mandates for assessment and mill levies.

July 1, 2001 our Public Works Trustee, Dick Dickerson, resigned from the Town Board with the sale of his residence in the Town. He continued as the Town Representative and Manager of the Fairway Entrance Project until its recent completion. Dick worked very hard improving the Town as Building Commissioner and more recently at Public Works Trustee and his counsel will be greatly missed by the Board.

We now welcome our new Public Works Trustee, Peter Grimm, who began learning the ropes in July. He has a long history in construction in the public works arena and will be a great asset to the Board. We are fortunate to have his expertise.

As always the Trustees welcome any comments on areas of concern or assistance for the Town. Please contact any one of the Trustees or the staff with questions or concerns.

Just a few achievements that have been accomplished while I served on the Board are projects like building a brick wall around the Town, new signs in the Town, taking the remaining homes out of the flood plain by completing Drainage Way E., building a new entrance at Fairway Lane, signalization of the intersection of Platte Canyon and Fairway Lane, annexing the Polo Reserve into our Town, building and maintaining Hunter Run Lane and finalizing plans for the two developments on the North side of Town.

I hope in the future, more people will get involved in the operations of Columbine Valley and help the Town continue being one of the greatest places to live in Colorado.

NOTES FROM PUBLIC WORKS

Snow Plowing: We ask that you keep vehicles off the streets when we are plowing as they narrow the roadway available to plow. The areas in which the streets are plowed is rotated every snow storm lest the same streets get plowed first every storm. Remember we always plow the main arterial streets first and then return to do the side streets and cul-desacs. We make every effort to plow the roads prior to morning traffic.

Materials in the street: Noting that many of us are remodeling, I remind you to get permission from the Town Office if you need to put materials (dumpster, rocks, sand, porta-potties, etc.) in the street. Normally, materials can remain on the street for 24 hours. It is very important to contact the Town Office regarding this situation, especially during the time we are working on the streets or re-asphalting. Any materials in the street must have cones or barricades around it.

PUBLIC SAFETY

In light of recent events, we all need to be aware of what is happening around us, inside the Town as well as outside. If you observe anything which does not seem normal, contact law enforcement IMMEDIATELY by calling (303) 795-4711. We would rather respond to a call that requires no action than to respond too late or not at all. Law Enforcement needs everybody's help to combat terrorism.

2001 Statistics: As of October, your police department has issued 291 summons, made 74 arrests, driven 29,129 miles, purchased 2,390 gallons of fuel and assisted nearby departments 162 times.

Overnight Parking: Please remember parking on the street is prohibited from 3:00 a.m. to 6:00 a.m. Vehicles found on the streets during this time will be ticketed. Please inform all of your guests so they do not get a parking ticket.

911 Response: When calling **911**, remember to unlock your door so that police and fire department personnel can get in the house.

Gopeds: Remember that Gopeds, ELECTRIC OR GAS POWERED, are NOT allowed in the Town.

BUILDING DEPARTMENT

Are you thinking about remodeling or an addition? Do you need a permit? Is there a tax liability if you make home improvements?

Generally a permit is NOT required when you repaint, re-carpet, replace concrete, replace vinyl flooring, or install hardwood floors. For the most part, all other installation or replacements DO require a permit. The cost of a permit is determined by the value of the improvements. The permit also contains a sales tax deposit on the materials.

We will be glad to help you through the permitting process, licensing, insurance and inspections so that all applicable building codes are met.

TIPS FROM BFI TRASH

- Bag all trash and place in blue tote
- Each address is allowed one bundle of construction material per week
- Cut branches into 4 foot lengths and tie in 18 inch diameter bundles/6 per week
- Empty liquids prior to placing in trash
- Large item pick up: call customer service (303) 287-8043, at least 24 hours prior to pick up day to arrange for a special pick up. Any charges are the homeowner's responsibility.
- Hazardous waste/medical waste:
 - Old needles/razor blades, etc. should be placed in a hard plastic container (detergent bottle) with lid prior to placing in trash
 - Broken glass or mirrors should be wrapped in newspaper and labeled.
 - Oil, gas, paint, insecticide, fertilizer, vehicle batteries, fire extinguishers, propane tanks are UNACCEPTABLE

Bird Sightings:

Judging from the proliferation of bird feeders and birdhouses seen in Town yards, we must have quite a number of bird watchers (birders) in our midst. Bird species frequenting our area are quite numerous.

In abundance are Canadian geese, Mallard ducks, starlings, grackels, common blackbirds, robins, house sparrow, magpies, red shafted flickers, and morning doves. Less common are red winged blackbirds, house finches, wrens, and black capped chickadees. Still less common are downy woodpeckers, blue jays, and white breasted nuthatches. A rare sighting recently was a tree full of yellow headed blackbirds and a flock of white faced ibis. Occasional visitors are western tanagers, Bullock's orioles, cedar waxwings, yellow rumped warblers, black headed grosbeaks and red tailed hawks. Perched in the top of a large dead tree in the South Suburban Park area, two bald eagles can frequently be seen from the town.

If bird watching is one of your hobbies and you would like to tell your fellow "birders" what, where, and when you have seen a notable bird, call Norm Kautsky (303) 794-3348 and he will see that the word gets around. With sufficient input, the Town newsletter will publish a summary of the summer sightings.



The Town anticipates continuation of street re-paving this summer in accordance with our multi-year plan.

One change this year is that the Town will be holding meetings for the Board of Trustees and the Planning and Zoning Commission in the newly renovated City of Littleton Courthouse on Littleton Blvd. The reason for moving to this location was based upon the Town's need to better utilize existing space in the Town Office for services to the community and provide enhanced space for visitors to these meetings.

On February 13, 2001 the Town received notification from the Federal Emergency Management Agency approving our request for a Letter of Map Revision removing Town residences from the Drainage Way E floodplain as of February 9, 2001. 
2001 A "Space Odyssey"

NOTES FROM PUBLIC WORKS

2000 was a very productive year. Brannan Sand and Gravel has been awarded the contract for construction of the traffic light at the intersection at Fairway and Platte Canyon. Construction should begin in March with completion scheduled for the summer. In conjunction with this, rebuilding the Fairway entrance will go out for bid in March for construction this spring/summer. I want to thank the citizens of the Town for their understanding regarding the delay in completion of the Fairway entrance.

The drainage system under Middlefield road near Village Drive has been revised to solve the water backup on Middlefield during heavy rainstorms.

In 2001, the Board will be looking at the feasibility/advisability of building a Town Hall on the property dedicated to the Town by Brookhaven.

The areas in which the streets are plowed is rotated every snow storm lest the same streets get plowed first every storm. Remember we always plow the main arterial streets first and then return to do the streets and cul-de-sacs. We make every effort to plow the roads prior to morning traffic.

PUBLIC SAFETY

A reminder that Go-Peds, either gas or electric powered, are **not permitted** on Town streets. If you are stopped by a Columbine Valley Police Officer, you may be issued a summons to appear in court.

Remember, there is **no parking** on the streets between 3:00 and 6:00 am. Vehicles found on the streets during this time **will be ticketed.** Please let you guests know so they don't get a parking ticket. You may request a special circumstances permit to park on the street for a limited time. Call the office at (303) 795-1434 for more information.

The Police Department requests you keep your garage door closed. Thefts occur when the garage doors are open and no one is in sight. The Officers will be glad to provide you with helpful tips on keeping your home secure.

PLANNING AND ZONING

The Planning and Zoning Commission had a very busy 2000. All you have to do is look around our Town and you will see the fruits of our work. The commission led by George Diachok, tackled many issues during the year. Most notable of these was the approval of Brookhaven Phases I and II on the north end of town. This new area will be a mixture of new two story custom homes and "empty nester" homes that will border the Villas and the golf course. Construction is expected to begin in the spring of this year.

A small eight-unit development called Country Club Villas will begin construction during the same time frame just west of Middlefield. These will be "southwestern" style patio homes. The Commission and Town Board anticipate these new homes will be an exceptional addition to the community.

We spent much of our time reviewing our regulations and have streamlined most processes. Additionally, we strengthened the regulations to provide additional protection of our community and lessen our liability. Many thanks to all our members, homeowner association members, staff professionals, and Town Administrator, Ann Jennings.

Remember the Planning and Zoning commission meetings are held the second Tuesday of nearly every month at 7:00 pm at the Littleton Courthouse.

The Town has a General Fund and a Conservation Trust Fund. The General Fund receives all revenues and pays all Town operating expenses. Revenues in excess of expenditures are placed in a reserve for capital expenditures including public works (paving). The Conservation Trust Fund is funded from the collection of Colorado Lottery receipts in which the Town shares. These funds are used for the Town's dedicated parks.

Revenues are derived from the following sources; sales tax and permit fees vary significantly based upon new home construction.

The Town is expecting to expend \$555,805 on operating expenses in 2001 and transfer the remainder of \$163,195 to its reserve fund for capital expenditures. Expenditures fall in the following categories:

Major public works for 2001 includes repaving Arabian Place (\$65,000) and a contribution to the Fairway Lane/Platte Canyon light project (\$25,000). Other capital expenditures include a new patrol car, miscellaneous street repairs and new equipment for the Town Office.

- Adding one through lane in each direction in I-25 from Logan St. to I-225.

- Adding 19 miles of double-track light rail, with 13 transit stations, which will connect the system from the existing Broad way Blvd. station to Lincoln Ave.
- Replacing 13 bridges, and widening nine others.
- Reconstruction the "Narrows" from Broadway Blvd. to Steele St.
- Reconstructing eight interchanges including I-25/I-225.
