A BILL CONCERNING

THE OPERATION OF GOLF CARTS

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF COLUMBINE VALLEY, COLORADO:

<u>Section 1</u>: Section 10.08.030 is amended in its entirety to read as follows:

10.08.030 Golf cart operation on roadway

- A. No person may operate a golf cart on the roadway of a street in the town except as provided in this chapter.
- B. No unlicensed driver of a golf cart may carry a passenger who is under twenty-one years of age.
- C. No person under the age of fourteen years may operate a golf cart, except upon lands owned or leased by his parent or guardian, unless he is accompanied by or under the immediate supervision of a person twenty-one years of age or over.
 - D. The operation of a golf cart on a State highway is prohibited.
- E. While being operated between the hours of sunset and sunrise, such golf cart shall be equipped with at least two front headlights emitting a white light visible from a distance of at least five hundred feet to the front as well as two tail lights visible from a distance of five hundred feet.
- F. Any person who violates any of the provisions of this chapter shall be subject to the penalties set forth in Section 10.04.030 of the Municipal Code.
- Section 2: That should any section, clause, sentence, part or portion of this Ordinance be adjudged by any Court to be unconstitutional or invalid, the same shall not affect, impair or invalidate the ordinance as a whole or any part hereof other than the part or portion declared by such Court to be unconstitutional or invalid.
- <u>Section 3:</u> The Town Clerk shall certify the passage of this Ordinance and cause notice of its contents and passage to be published.
- Section 4: This Ordinance shall be in full force and effect upon the expiration of thirty (30)

days after the publication of this Ordinance in the Littleton Independent, Littleton, Colorado, said newspaper being a weekly newspaper duly qualified for publishing legal notices and advertisements within the meaning of the laws of the State of Colorado.
