WILD PLUM DEVELOPMENT UPDATES

On February 12, Lennar completed its merger with CalAtlantic, the developer of Wild Plum. At this time, the merger is not anticipated to impact the development scheduled or design of Wild Plum in any way. The Town will continue to monitor the situation as progress continues.

The new wall along the north side of Hunter Run Lane is complete and the temporary traffic signal has been installed at the intersection of Hunter Run and Thoroughbred. The 13 Tuck family buildings on the property have bee demolished and earth work and grading has begun.

The Town and Lennar are dedicated to keeping the construction of Wild Plum as unobtrusive as possible on existing Columbine Valley residents. A a part of this effort, the Town has brought on a contract employee, Joanna Czarnecka to serve as the Senior Construction Manager. Joanna's job will be to ensure that Lennar and its team adhere to the final development plan, design guidelines, construction management plan, and town municipal codas they construct Wild Plum.

CV Street Program —PAVE '18

One of the Town's priorities is to maintain an infrastructure that prioritizes safety, enhances mobility, and preserves the character of Columbine Valley. The Town's 9+ miles of asphalt roadways are one of the most important public assets with a replacement value of over \$10 million. The Town has a long established management program in place to maintain, repair, and replace the roads based on engineering criteria established by a consortium of local governments.

The Town is now entering the 5th and final year of a multiyear plan to bring current maintenance work on every road in Columbine Valley. Repairs and slurry seals were completed in the Burning Tree and The Village in 2014 and similar work was completed in Polo Meadows, Brookhaven, the Columbine Villas and Country Club Villas in 2015. Slurry seals and other road repair work on Wedge Way, Niblick Lane, Middlefield Road, and the back stretch of Fairway Lane starting at Brassie Way was completed in 2016 and last year the focus was on Fairway Lane. Club Lane, and the rest of Middlefield Road. This year, the Town will look to complete work on Fairway Lane, including the stretch between Platte Canyon and the Country Club, and along the Wild Plum development. Planning is in its early stages and more information will be presented as it becomes available.



LITTLETON FIRE PROTECTION DISTRICT/SOUTH METRO FIRE MERGER

At their February meeting, the Board of Trustees passed a resolution supporting Ballot Question A, to appear in an election on May 8, 2018 to receive approval from the eligible voters within Littleton Fire Protection District to expand South Metro Fire's jurisdictional boundaries to their area. The Inclusion Election is the first step in the proposed unification of South Metro and Littleton FPD.

LFPD covers 80,000 residents in Columbine Valley, Bow Mar, the area around Chatfield Reservoir, the western portion of Centennial, and a large area of unincorporated Arapahoe County west of the Littleton city limits. The district owns three fire stations and shares ownership of a fourth with the city, according to a news release. The district's stations are staffed by firefighters from Littleton Fire Rescue, which is the City of Littleton's firefighting agency. South Metro Fire Rescue is a large consolidated district that provides fire protection services to a vast area in the southeast metro area suburbs, including Parker, Lone Tree, Greenwood Village, Castle Pines and a large chunk of Centennial.

The Columbine Valley Board of Trustees understand the need for essential services, financial certainty and stability in the management of a governmental entity; and believe it to be in the best interest of the health, safety, and welfare of the citizens of the Town of Columbine Valley in general to support this ballot proposal.





PRESCRIPTION DRUG TAKE-BACK DAY

The Town of Columbine Valley will host a prescription drug collection point at the Town Offices on April 28th from 10 AM to 2 PM. The event is designed to significantly reduce the prescription drugs in homes that are either no longer needed or outdated/expired. Medications should never be disposed of in your water evacuation systems, or given to others the medication was not intended. Law enforcement is the only entity legally able to accept these medications and process them properly so that they do not fall into the wrong hands.

Please drop off your unused or expired medications at Town Hall on April 28th between 10 AM to 2 PM to a uniformed Columbine Valley police officer for proper and safe disposal of these drugs so they don't become a future problem.

CONCERTS IN THE PARK

The Town of Columbine Valley is excited to announce the 2018 Summer Concerts in the Park series, sponsored by Vectra Bank.

SPRING CLEANING EVENT

The semi-annual dumpsters will be placed in the parking lot at Town Hall from noon, Thursday, May 17th until noon on Saturday, May 19th No LANDSCAPE MATERIALS or HAZARDOUS MATERIALS are allowed. Such materials include oil-based paint, mercury, gasoline, de-greaser, cleaning compounds and garden chemicals. The Town offers an event in the fall at which these products can be safely disposed of.

Please do not put electronics, refrigerators or other major appliances in the dumpsters. The Town will have a recycler on hand to take away any of these items you want to get rid of. He will also take away these items throughout the year. The Town office will be the collection site but please call first to ensure the items you have are eligible for this program. There is a fee for television recycling: \$20 under 26"/\$50 for 26"+.

Vehicle batteries, tires and oil should never be disposed of in your home trash container or dumpster, or poured into any type of drain. These materials can be easily recycled instead. Most automotive shops and stores accept car batteries and used motor oil for recycling at no charge. Car tires may be recycled at tire shops when you purchase new tires.

MUNICIPAL ELECTION CANCELLED

The town of Columbine Valley's April 3 municipal election has been canceled due to a lack of candidates. Per Colorado law, if the number of candidates filing for office is equal or less than the number needed to fill the positions, the election may be cancelled.

The deadline to file candidate petitions was on January 22. At that time the town had received three petitions for the available Board of Trustee seats and one petition for the mayor's seat.

The three candidates who filed petitions for town Trustees are incumbents Kathy Boyle, Bill Dotson, and Bruce Menk. Current Mayor Richard Champion was the only candidate to file for Mayor. Current council members David Cope was term limited and could not run again.

The three returning Trustees will serve 4-year terms and the Mayor will serve a 2-year term. They will be sworn in at the April 17 Board of Trustees meeting.
