

DEVELOPMENT UPDATES

Lennar has indicated that they are considering an offer for the Wild Plum development. The Town is not aware of the details of any agreement, and at the time of publication, no deal has been finalized.

Regardless of who builds the homes in Wild Plum, the architectural designs approved with the Final Development Plat and Plan must be followed. If a new builder wanted to introduce alterations, additions, or changes of any substance, they would be required to seek approval from both the Planning and Zoning Commission and Board of Trustees in the same process CalAtlantic/Lennar went through in 2016, including at least two public hearings. If and when more details immerge, look for updates from the Town in this newsletter and on the website.

The construction on Fairway
Lane has finished. While some
small repairs, striping and landscape fixes have yet to be
completed, the bulk of the work is
done. The projected one month
project met one unanticipated
obstacle after another and turned
into eight months with torn up
streets, dust and mud. A very sincere thank you to all the residents
who live on or beyond this project
for their patience and
understanding throughout.



2019 TOWN MASTER PLAN UPDATE

The Planning and Zoning Commission continues its work on updating the Town's 2007 Master Plan document. The Master Plan is a guiding document that outlines the Town's vision, priorities and goals for the future, specifically related to development and infrastructure. Beginning in January, the Commission has worked chapter by chapter through the document, informed by two public open houses and two online surveys.

In addition to always being invited to Planning Commission meetings, the public can expect additional opportunities for engagement and feedback at the Town's summer events and at future commission meetings. Upcoming chapters include transportation and parks, trails and open space.

The final plan will be presented to the Trustees in October or November.

Metro Plex—Airport Noise Issues

Over the past few months you may have heard about the Federal Aviation Administrations (FAA) Metroplex. Metroplex—Denver is part of the FAA's effort to modernize the national air transportation system with the goal of increasing aviation safety, efficiency, capacity, predictability and resiliency.

At this time, it is unknown how Metroplex will impact Columbine Valley. Initially, there were concerns that there would be a significant increase in the number of overhead flights, flying at a substantially lower altitude in rout to land at DIA and Centennial Airports.

While these concerns have been lessened as additional information is presented, your elected officials continue to actively monitor this situation and advocate on behalf of Columbine Valley residents and the quality of life in Town. Updates will be posted online as necessary.



CVPD REMINDERS

FIREWORKS

Fireworks that leave the ground or explode are illegal per State Statute.

Anyone found lighting such fireworks will be subject to a citation from the Police Department.



GOLF CARTS

Please remember the ordinance regarding the operation of golf carts has been revised. Only a LICENSED driver at least 16 years old may operate a golf cart on public roadways of Columbine Valley. In the interest of safety, golf carts are considered a motor vehicle and therefore are regulated by the same traffic laws. The Columbine Country Club maintains a separate set of rules for operation on the golf course; these rules are not applicable to public roadways.
