I estimate that over 100 golf carts participated in the parade and the crowd was well over 400 residents. Denver Water Project on Platte Canyon Road

As part of Denver Water's continuous effort to maintain and replace aging infrastructure, starting in September 2019 Denver Water crews will be replacing approximately 900 feet of water main along South Platte Canyon Road between West Christensen Lane and Fairway Lane. The purpose of this project is to increase capacity in the water system in your area to accommodate new residential developments.

The majority of the work is being conducted at night, and access to Columbine Valley via Fairway Lane will be closed for several days. Traffic will be impacted during the installation of the new 12-inch main along South Platte Canyon Road. One lane of through-traffic will be maintained in both directions. Additionally, the work may include impacts to the Columbine Valley bike path. A pedestrian and bicyclist bypass around the construction will be used while the bike path is impacted.

WILD PLUM UPDATES

The Wild Plum development will remain in the control of Lennar, with Toll Brothers choosing not to proceed with the vertical development of the 84 homes on the interior of the property. Lennar has indicated to the Town that they are “full speed ahead” with construction of model homes anticipated to begin in early 2020.

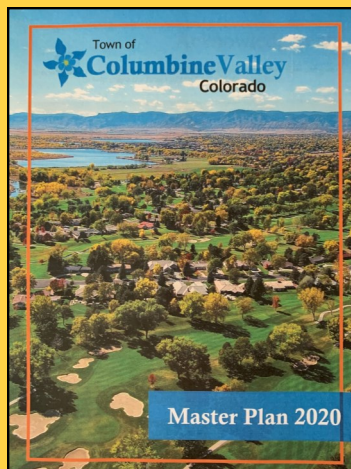
Items still to be completed over the next four weeks are primarily landscape related but also consist of small roadway, concrete, and trail repairs. Ongoing projects include completing the upper detention pond, site irrigation, fine grading and reseeding, installation of feature walls, mail kiosks, finishing up fire pit and plaza, finishing up retaining walls, finishing crusher fines trail by the ditch, finishing fence across rundowns, revegetation on Cooley Lake open space areas, bollard installation, finishing signs and installing the boardwalk.

Once these projects are completed, the Town will perform another site inspection to review all landscaping, infrastructure and utilities. Repairs are also scheduled for Hunter Run and there remains some finish work to be completed along Platte Canyon Road.

2020 Master Plan Work Concluding Soon

The Planning and Zoning Commission is in the final stages of drafting an update to the Columbine Valley Master Plan, last reviewed in 2007. Since January, the Commission has been working with Town staff and consultants to develop a plan which will guide the decision makers of the Town for the next 5-10 years. In doing so, they have engaged the public in numerous town halls, digital and mail surveys, outreach booths at summer concerts, and through opportunities for public comment at the monthly Planning and Zoning Commission meetings. Public comment has provided important information and direction to the Commission as they draft various chapters in the plan including Parks, Trails and Open space, Transportation, Landuse, and Stormwater Management.

Citizens will have another chance to comment at a Public Hearing, scheduled for Tuesday, October 8 at 6:30p.m. at the Columbine Valley Town Hall; after hearing from the public the Planning Commission will consider adopting the final document and referring it to the Board of Trustees for action at the November Trustees meeting. To review the complete Master Plan draft, or to ask specific questions about the draft, the process for development, or the use of the Master Plan, please contact the Town Planner at Town Hall.

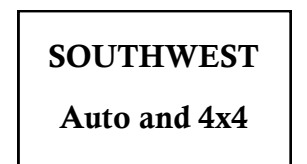
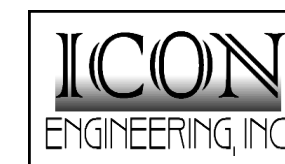
**History of Columbine Valley:

Columbine Valley Police Ask You:

- Please remember to always lock your house, garage and car doors at all times. Keep valuables out of sight or secured in your home and keep in mind that if your car is unlocked criminals have access to your garage door opener and other personal information.
- Don't forget that overnight Parking in Columbine Valley is prohibited between 3:00 a.m. and 6:00 a.m. If you must park on the street overnight, call the Town office for a temporary permit. If you need a permit before or after the Town Hall hours of 8:00 AM and 4:00 PM or on weekends, please call Arapahoe County Dispatch at 303-795-4711 and ask for a Columbine Valley Police Officer so that you may notify them that you will need to park overnight. Please be certain your guests are made aware of this ordinance so that embarrassing and annoying tickets can be avoided.
- Visit us online to register for the Columbine Valley residents House Watch program. Anytime residents will be absent from their home for a vacation, long weekend or business trip, please complete the online House Watch form on the Town's website, Columbinevalley.org. Simply type in your information; the police will then be aware to look for any strange activity at your home.

Capital Improvement Program

At their August meeting, the Board of Trustees adopted the Capital Improvement Program (CIP) for 2020. This document outlines capital expenses for the coming year, and anticipates future needs of the Town for the next decade. It is an important planning and budgeting tool that identifies non-reoccurring, capital projects and equipment purchases, provides a schedule estimating when those costs will be incurred and estimates how much each project will cost. The CIP also identifies options for financing the plan including grants, federal, state or county funds, and developer contributions.

The 2020 CIP includes immediate projects such as repairs to the drainage way between Burning Tree (Spyglass) and Old Town (Fairway), and longer-range projects including a study of sidewalk feasibility along Platte Canyon between Village Court and Ponds Circle. The total 2020 outlay will be \$124,000. To learn more, view the 2020 CIP on the Town's web site at: columbinevalley.org/capital-improvement-program.

PUBLIC WORKS PROJECT UPDATES (& SNOW REMINDERS)

There was no major road work conducted by the Town in 2019, with the exception of the Fairway Lane expansion adjacent to Wild Plum, and nothing is planned for 2020 as the Town's roadwork infrastructure is in solid condition. There have been a few concrete pans replaced as needed throughout Columbine Valley and the town will conduct crack and seal treatments as necessary this fall.

A small sinkhole will be repaired at the intersection of Par Circle and Middlefield Road before the end of the year and Public Works continues to replace the old concrete light poles throughout Town as needed.

Snow is just around the corner and the Town of Columbine Valley is getting ready. Snow operations consist of three elements: snow plowing, application of traction materials and ice control.

Snow plowing will begin when the snow depth reaches ½" of accumulation on the roads and the objective is to have all roads clear within 24 hours of the snow having stopped falling. Crews will plow based on established routes, with main roads being plowed first followed by feeder streets. After an initial pass by snow crews a second pass will occur to clear snow from gutter-pan to gutter-pan within 24 hours, while ice build-up and other clean-up operations may take several days depending on weather conditions.

The Town also distributes ice slicer as needed for traction and safety. These operations will be limited to hills, intersections and curves and may be applied before, during or after snow events depending on conditions.

To report a snow-related problem during normal business hours, Monday – Friday, 8:00 AM to 4:00 PM please call 303-795-1434. For snow emergencies after business hours or during weekends or holidays call Arapahoe County Dispatch at 303-795-4711 and ask to speak to a Columbine Valley Police Officer. ICE SLICER: The Town applies a product called Ice Slicer to the streets before or after freezing rain or snow events depending on temperatures and conditions, and whenever ice is present on the street surface. It is applied at all intersections, steep hills and sharp curves.

Ice Slicer is a naturally occurring salt that is mined and shipped from Southern Utah. It is a material that both Littleton and CDOT use regularly and comes from the same deposit as Real Salt, the #1 selling food grade sea salt that is sold in health food stores. It contains micro-nutrients that should not harm pets or lawns.

Columbine Valley Fall Community Programs

The town is once again prepared to help residents as they clean up and clean out for winter. We have several events coming up to help as you prepare your home and garage for winter.

The Town will once again be partnering with Front Range Flu Shots to offer seasonal shots to members of the community on Monday October 7th between 7:30 – 9:00 am and between 5:00 and 6:30 pm. The shots range in price and insurance cards must be presented at the time of service. Co-payments may apply.

Pre sign-up is not required but is appreciated. To sign up for the Nasal Spray or High-Dose shot, please call Town Hall at 303-795-1434.

There will be an **on-site shredding service** in the Town Hall parking lot on Saturday October 12th from 9:00 a.m. to Noon. Residents may bring any documents and records they would like destroyed safely and can witness their destruction. Unacceptable items are vinyl notebooks, phone books, newspapers and hard back books. They will destroy/shred CDs, DVDs, hard drives, floppies and videos, but can only perform this service off site, where the owner of the shredding company witnesses all destruction. It is required that all such materials be kept separate from the paper when brought to the Town Hall. All shredded paper will be recycled in an environmentally friendly manner.

The **dumpsters** will be placed at in the parking lot at Town Hall from noon, Wednesday, October 16th until noon on Friday, October 18th. No landscape materials and NO HAZARDOUS MATERIALS allowed. Latex paint is not a hazardous waste, and can be safely disposed of with your regular household garbage once it is dried and no longer liquid. To dry latex paint, remove the lid from the paint cans, mix in an absorbent to speed the drying process (such as kitty litter, dirt or sand) and allow the paint to dry completely before disposing with your regular trash pickup. Once the two dumpsters are full there is no additional dumping.

As always the Town offers to all residents free **Electronic disposal** (\$20.00+ fee for televisions). Bring electronics to Town Hall during normal business hours. For a complete list of acceptable items, visit www.columbinevalley.org/electronic-drop.

The Town will host a **prescription drug collection** point at the Town Offices on October 26th from 10 AM to 2 PM. The event is designed to significantly reduce the prescription drugs in homes that are either no longer needed or outdated/expired. Medications should never be disposed of in your water evacuation systems, or given to others the medication was not intended. Law enforcement is the only entity legally able to accept these medications and process them properly so that they do not fall into the wrong hands.

Please drop off your unused or expired medications at Town Hall to a uniformed Columbine Valley police officer for proper and safe disposal of these drugs so they don't become a future problem.
