Recycling Reminders

To ensure what you put in recycling bins actually gets recycled, remember these guidelines:

- NEVER put your recyclable items in plastic bags! It fouls the sorting equipment
- Break down cardboard boxes. It will open up space in your bin.
- Rinse food jars, bottles and cans before recycling them.
- Don't recycle pizza boxes! The grease prevents them from being recycled.

Trash Can Reminder

Please be reminded that in Columbine Valley your trash and recycle containers must be kept out of view from the public right-of-way except when they are at the curb on pick-up day. Check with your HOA about any specific storage regulations.

Mosquito Control Program

The Columbine Valley Mosquito Control Program has three main components: weekly larval site inspections, weekly surveillance traps – used to collect, count and speciate adult mosquitoes, and as-needed truck fogging determined by trap counts designed to control adult mosquito activity. The Town does not engage in automatic weekly fogging.

When fogging is appropriate, the Town only fogs late in the evening or at night, and when it is not windy, which helps control where the adulticide is distributed helping protect, among other things bees and aquatic life in the nearby Platte River.

It is safe to remain outside when fogging occurs, but individuals may choose to go inside and batten down the hatches; this decision depends on personal sensitivities. In any case, all remnants from the fog trucks should be undetectable within a few minutes of the truck passing by.

Residents can be placed on a call list which notifies residents when spraying will occur in Columbine Valley. If you would like to learn more, please visit Columbine Valley.org/mosquitos.



SPRING CLEAN-UP EVENT

There will be an on-site **shredding service** in the Town Hall parking lot on Saturday May 8, 2021 from 9:00 am to Noon. Residents may bring any documents and records they would like destroyed safely and can witness their destruction. Unacceptable items are vinyl notebooks, phone books, newspapers and hard back books. CD's DVD's, hard drives, floppies and videos will be accepted for destruction but this service can only be performed off site, where the owner of the shredding company witnesses all destruction. It is required that all such materials be kept separate from the paper when brought to the Town Hall. All shredded paper will be recycled in an environmentally friendly manner.

The **semiannual dumpster events** have been suspended at this time. The Town is working with Republic Services to develop a program to benefit residents in the future. The event has become increasingly popular in recent years and due to over-use and abuse could not be supported at this time. Town staff is hopeful that an announcement about future programs will be made soon. Large item pick-up can be arranged privately by calling Republic Services.

The annual **Hazardous Material Round-up** is still scheduled for September 4th and 11th.
