From the Mayor:

As Mayor, I am frequently asked about the cost of building permits in Columbine Valley ... and why they are so expensive. Most recently this came from the contractor who is remodeling our home. The short answer is Columbine Valley collects sales and use tax at the time the permit is issued, where most municipalities collect at the point of sale. So, while Columbine Valley is not the most expensive building permit fee in the state, we do collect more up front.

But remember, the sales and use tax we collect through building permits is a large percentage of our Town revenue. In addition, the Town gets a small portion of your property taxes (about 7%), and retail sales tax from every single business in the Town ... (which is only one; Columbine Country Club). Most Towns have many retail businesses, and they are primarily funded by the resultant sales tax. We have but one.

The Town recognizes that all the Wild Plum, Wilder Lane and Willowcroft revenue is one-time. There are not any more large, undeveloped parcels left in our boundaries. That is why we are banking these one-time revenues and have created a capital projects reserve fund that is now over \$1.5 million and growing. This will be used to pay for expected, future road and public works projects.

What we aren't doing is spending the "construction windfall" on current operations. Our operating budget roughly increases as the cost of labor and inflation increases. There will come a time when the scrapes and re-models slow down dramatically ... and I believe Columbine Valley will be well positioned to withstand that, without having to raise taxes.

ENTRANCE SECURITY TRIAL

Beginning in July Columbine Valley will be testing security cameras at seven entrances to the town: Hunter Run; Burning Tree; Fairway Lane; Middlefield Road; Village Drive; Wilder Lane; and Brookhaven from Bowles. These cameras are a product offered by Flock Safety. They record and manage data from every vehicle entering the town at the specific locations where they are installed. Among the data the system is able to record are the color and make of the vehicle, the license plate number and the specific time the vehicle entered the town. The system does not record any images of the occupants of the vehicles, only information related to the vehicle.

Statistics show that approximately 70% of all crime involves the use of a vehicle. This system is currently in use by over 500 law enforcement agencies in 36 different states. Bow Mar, which is served by the Columbine Valley Police Department has Flock cameras installed and our police have been successful resolving a number of criminal matters based on the evidence captured by the cameras.

Data captured by the cameras is stored on a cloud system and can be accessed by police for 30 days. The data can be sorted in a variety of ways to identify certain types of vehicles, license plate numbers, the number of times a particular vehicle entered the town, etc.

The system is also programmed to immediately identify certain license plate numbers known to be associated with criminal activity such as stolen vehicles or plates. When detected, this type of information is immediately sent to our on-duty officers in their patrol cars.

The testing of this system is intended to give CVPD officers more exposure to the use and effectiveness of it, and to give our citizens time to see and understand the system. Based on the feedback from both the police and our citizens, the Board of Trustees will decide whether to permanently contract with Flock for continued use of the cameras and their technical support. Consequently, we encourage you to provide your thoughts over the 60-day trial period.

RECYCLE SERVICE CHANGES

Republic Services is changing the schedule for recycle pick-up in Columbine Valley. Service will remain on Mondays of every other week, but the schedule will shift by one-week starting on Monday, June 7. That means that recycle will be collected as planned on Tuesday, June 1 (accommodating the Memorial Day Holiday), and then again on Monday June 7 and every other week after that. The schedule has been updated on the Town website's Community Calendar but the calendar in the 2021 Town Directory is no longer correct. We apologize for any confusion or inconvenience this may cause.

PICK-UP AFTER YOUR POOCH

At their May meeting the Board of Trustees adopted a new ordinance specifically prohibiting the deposit of dog or cat excrement on public, HOA, or private property other than the animal's owner or requiring the immediate collection of such waste for proper disposal. This ordinance is the result of an increase in un-neighborly behavior by some pet owners. Violators can be fined or cited by police. Call Town Hall if you have any specific questions.
