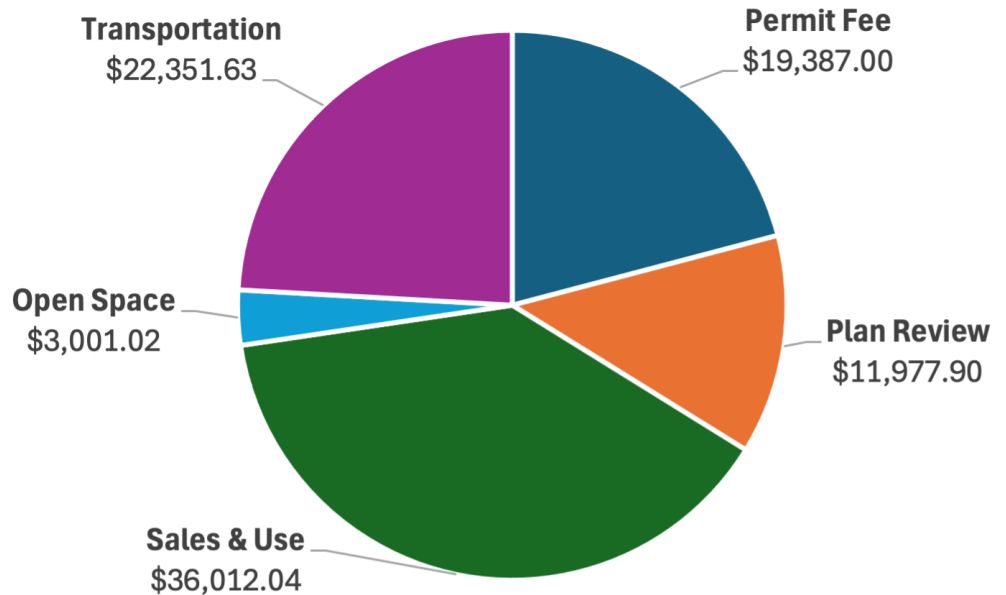

Public Works Updates

Snow Removal Updates

- The Town’s new snowplow driver, Andre, was able to plow his first full shift in January. He brings multiple years of plowing parking lots and is excited to get more street plowing experience.
- After years of plowing with rubber cutting edges, Public Works is trying out newer products, such as polyethylene, that will last longer and provide a similar finish.



Fleet Improvements

- To provide more awareness to drivers and pedestrians, additional blue and amber strobe lights were installed on the F450. Snowplow drivers will use the lights when spreading salt and plowing.
- GPS tracking was added to the F450.
- A short in the Expedition plow light was located and fixed.

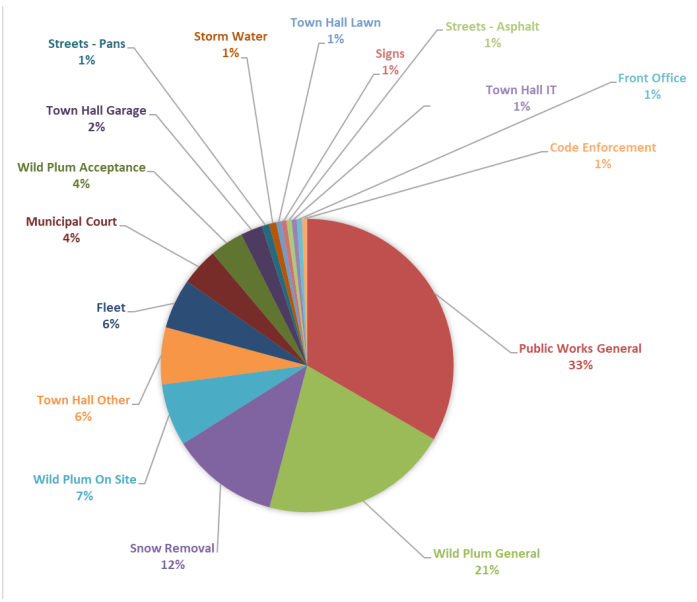
Boardroom Lighting

- The boardroom lighting was re-evaluated after multiple ballasts and battery backups failed.
- LED options were reviewed due to the nationwide phaseout of fluorescent tubes.
- A quarter of the fluorescent lights were changed over to LEDs with matching color temperature and brightness.
- The new lights run cooler, use less electricity, and don’t require ballasts.
