BOARD OF TRUSTEES

Minutes

August 19, 2025

Mayor Dotson called the Regular Meeting of the Trustees to order at 6:30 p.m., in the Conference Room at the Town Hall at 2 Middlefield Road, Columbine Valley, Colorado. Roll call found the following present:

PUBLIC COMMENT: Kathy Boyle, 6 Club Lane, shared several questions she wanted addressed regarding the Intrepid Fiber agreement the Trustees would be considering.

CONSENT AGENDA

ACTION: Upon a motion by Trustee Giesen and a second by Trustee Huelskamp, the Board of Trustees unanimously approved the consent agenda with corrected minutes.

REPORTS

- A. Mayor Dotson thanked staff for their work on the summer concert series. He also provided an update to the Trustees on the local challenges to the recent ADU laws in the State.
- B. No Trustee offered any comment.
- C. Mrs. Rodriguez presented the financials shared in the packet. The mayor expressed his hope the Town could maintain the current levy rate.
- D. Mr. McCrumb presented his report to the Trustees. He shared that SMFR would be placing a mil levy question on the November ballot.
- E. Chief Cottrell presented his report to the Trustees. He informed the Trustees that the Town would be contracting a new provider for PD cameras.

PRESENTATIONS:

Intrepid Fiber in Columbine Valley: Representatives from Intrepid Fiber Network presented to the Trustees. The Trustees asked clarifying questions.

OLD BUSINESS:

There was no old business.

NEW BUSINESS:

- A. **Appointment of New Trustee:** Mayor Dotson recommended that Jeff Sahr fill the seat made vacant by his assentation to mayor.
ACTION: upon a motion by Mayor Dotson and a second by Trustee Huelskamp, the Board of Trustees unanimously approved Jeff Sahr as Trustee. Trustee Sahr will officially be sworn in and seated in September.
- B. **Appointment of Planning and Zoning Commissioner:** Mayor Dotson recommended that Jameela Khadiwala be appointed to a position as Alternate Commissioner on the Planning and Zoning Commission.
ACTION: upon a motion by Trustee McCain and a second by Trustee Icenogle, the Board of Trustees unanimously approved Jameela Khadiwala as Alternate Commissioner.

ADJOURNMENT: There being no further business, the meeting was adjourned at approximately 7:41 p.m.
